Independent Study

Independent study provides opportunities for the capable student to do special work under individual supervision in areas not covered by class offerings. Undergraduate students should demonstrate qualities necessary for interested and intensive inquiry. The topic and outline must be agreed upon by the student with the approval of the instructor and department concerned. The following policies apply:

- x Independent study projects (3991 undergraduate, 4991 master's, 5991 doctoral) appear on the stude introduction the specific topic as the countine.
- x Academic grades (AF) areassigned.
- x Projects must be undertaken within the academic term in which the grastered.
- x The student must be in academic good standing (e.g., 2.0 GPA for undergraduates, 3.0 GPA for graduate students). Undergraduatestudentstaking businessindependentstudiesmusthavejunior standing, aminimum 2.4 GPA, and have completed at least 45 quarter hours at the Universit perior.
- x Independent study may not be taken instead of, or to modify a regular course offended by transent.
- x Independent Study forms may be obtained in the Office of the Registrar. Partial applications will more beed.
- x Registration after published registration dates ispenditted.
- x Independent studies must be at least one credit hour and generally do not exceed five hours. Undergraduates may apply a maximum of ten quarter hours toward degree requirements (except students in therbanders).
- The responsibilities of the instructor of record are: a) see that the grades are submitted; b) approve thetody, see of c) approve the credentials of other faculty involved; d) agree to assume responsibility if problems arise.

Independent Research

Independent Research opportunities are available to students for dissertation and thesis research or other independent research. The following policies apply:

- x Independent research projects (course numbers generally ending in 995) appear on the standscritist twith the specific topic as the courside.
- x On successful completion of the project or on its termination by request of the department, the research adviser will record a final grade. The department may use the partment may use the partment in evaluating the research or record 'P' (pass) or 'F' (fail).
- x Projects must be undertaken within the academic term in which the gastered.
- x Students obtain applications from their academic department or the Office of the Registrar. Partial applications will not be processed.

- x Directed study courses (1992, 2992, 3992, 4992, 5992) appear on the student's transcript with the spectifle.course
- x Projects must be undertaken within the academic term in which the grastered.
- x There can be no change in the basic content of the course. In particular, this means the level, subject code, description, title, grading policy (AF, P/NP), credits, and course content cannot differ from the permanese.
- x Directed studies use the same forms and processes as independent studies prizations will not be processed.
- x Registration after published registration dates ispermitted.
